

VENDOR AGREEMENT & INFORMATION

MUST BE COMPLETED IF BBQ COMPETITOR ALSO WANTS TO VEND ANY FOOD ON-SITE

As a condition of participation in the Viking Grillfestivalen, the undersigned agrees to the following:

1. This event shall take place at the following location: Brazos Park East, Martin Luther King Blvd. & Herring Ave, Waco, TX 76704.
2. The Viking Grillfestivalen is produced by Vanguard College Preparatory School (Waco, TX) and the Vanguard Viking Parent Crew, hereafter known as Event Producer.
3. This event is based on a first come, first served basis. Event Producer reserves the final right of refusal to any and all vendors. Vendor application will only be considered if completed in full. This event will not have more than one vendor selling the same food item (except BBQ Foods, which include BBQ competitors and non-competitors). Vendor fees are based on type of product (food or non-food) being sold. Fees are to be paid in full prior to the event date and are non-refundable.
4. The ONLY beverages that Food Vendors may sell in their booths are tea or lemonade made from instant mixes; they may NOT sell canned/bottled products including water, Coke/Pepsi, Snapple, etc. No Alcoholic beverages will be sold or distributed by anyone. Consumption of alcohol during this event shall be prohibited.
5. The event takes place rain or shine, with no "Rain Delay" scheduled. Event Producer reserves the right to cancel the event in whole or in part. In the event of a full cancellation, Vendors shall be refunded their booth fees no later than November 8, 2019. In the event of partial cancellation, no refund will be provided. "Cancellation" shall mean that a Vendor has no opportunity to make any sales due to Event Producer's Actions, not due to weather conditions. The Event Producer does not guarantee a particular number of attendees or exhibitors at this event.
6. Food Vendors agree to follow all guidelines of the Texas Health Department for food service, including set up and use of hand-wash stations. Only hoses marked for potable water use may be hooked to the on-site water supply. Pets must be leashed.
7. Liability insurance is NOT required but is strongly recommended for Vendor, as this is a public event.
8. All items sold, represented or distributed are subject to approval of Event Producer. No flammable items or hazardous materials are allowed. Weapons, controlled substances or similar materials will not be permitted on the premises.
9. Vendors will not be permitted to dump any ashes, grease or gray water anywhere on the event site, or anywhere else except in the designated receptacles provided by Event Producer.
10. Vendors shall continually police their area for safe and sanitary conditions. At the conclusion of the event, each Vendor shall be responsible for their own trash removal and shall restore the area to an acceptable condition, as inspected by a designee of Event Producer. Vendor will remove waste from within their booth, and dump in the nearest dumpster located on the event site. The event
11. The event will be open for set-up from 8:00AM-10:30AM on Saturday, November. No vehicles will be allowed access on-site after this time without Event Producer's prior consent. Vendors with larger rigs are recommended to arrive early. All booths must be set by 10:30AM on Saturday, November 2.
12. Regular assigned Vendor hours are approximately 11AM to 5PM on Saturday, November 2. Vendor break-down may not occur until 5PM on Saturday, November 2 unless another time has been agreed upon by both parties.
13. Vendor hereby grants permission for Event Producer and/or agents authorized by them, to use any photographs, videotapes, motion pictures, recording and any other record of this event for any legitimate purpose.
14. COMPLIANCE WITH LAWS: Vendor is responsible for researching and complying with all permits, fees, licenses and any other requirements as outlined by the State of Texas, the City of Waco, Texas Health Department and all other local, county, state and federal agencies. Vendor is responsible for paying Texas State Sales Tax.

15. HOLD HARMLESS: In recognition that there may be some risk, injury or property damage in such an undertaking at the Viking Grillfestivalen, the undersigned Vendor releases and holds harmless Event Producer, any and all of its members/officers, and the City of Waco for any and all liability for injury or damages to the Vendor, or which may result from their participation, or which may occur to third parties by the act(s) of the Vendor, their employees or agents. No action will be asserted or maintained against Event Producer and any or all of its members/officers and or sponsors including but not limited to the City of Waco as a result of any occurrence in any way with the Viking Grillfestivalen. Further, the Vendor shall defend any action so asserted or maintained arising out of any action taken by the Vendor, their employees or agents.

16. LIABILITY: As between the parties, each party shall be solely responsible for any and all liability arising from personal Injury, including death, or damage to property arising from the act or failure to act of the Respective Party or of its officials, Agents and Employees pursuant to this agreement.
